Tuvalu Whole of Government Audit For the year ended 31 December 2008

To: Honorable Members of the Tuvalu Parliament

Audit Opinion

In my opinion (except for the effects of the matters referred to in the qualification paragraph below),

- the accounts have been faithfully, but not properly kept and presented;
- the financial report of the Whole of Government presents fairly the Government's financial position as at 31 December 2008 and its performance for the year ended on that date, has been prepared using the principles of accrual accounting but has not been presented in accordance with generally accepted international accounting practice as prescribed by the Public Finance Act 1990 and the principles of accrual accounting;
- Expenditure has been applied for the purpose for which it was authorised; and
- Transactions with or concerning public money or property have been authorised by or pursuant to the Constitution and any other written law.

Qualification

The following areas need to be addressed satisfactorily in order to move towards having an unqualified audit opinion (in order of materiality):

- Material departure from generally accepted accounting practice (GAAP) in the non-preparation of financial statements in accordance with GAAP;
- A limitation of scope due to the inability to obtain satisfactory explanations and documentation regarding a number of material entries in the financial statements;
- Uncertainty in quantifying the extent of the government's liabilities and commitments in respect to the operations of Air Fiji Limited. This was due to the inability to obtain confirmations from the bankers of Air Fiji and its holding company Aviation Investments Limited relating specifically to guarantees given by the government; and
- Opinion matters raised in 2007 that still remain the case in 2008 in relation to:

- non-consolidation of state owned enterprises
- non-capitalisation of fixed assets and inventory
- expenditure exceeding approved budgets
- netting of income and expenditure in the statement of financial performance
- capital items still being captured in the statement of financial performance
- non-audit of budget assumptions

My opinion should be read in conjunction with the rest of this report.

Scope

The Financial Report and Finance Minister's Responsibility

The financial report should comprise the balance sheet, income statement, and accompanying schedules explicitly required under section 31 of the Public Finance Act (1990) for the Tuvalu Whole of Government for the year ended 31 December 2008.

The Minister of Finance is responsible for the preparation and true and fair presentation of the financial report in accordance with the Public Finance Act (1990). This includes responsibility for the maintenance of adequate accounting records and internal controls that are designed to prevent and detect fraud and error, and for the accounting policies and accounting estimates inherent in the financial report.

Audit Approach

I have conducted an independent audit in order to express an opinion on the financial report. I have audited the accounts of the Government of Tuvalu for the year ended 31 December 2008 in accordance with section 172 of the Constitution and section 32 of the Public Finance Act (1990).

My audit provides *reasonable assurance* to Members of the Parliament of Tuvalu that the financial report is free of *material misstatement*.

My audit was conducted in accordance with International Auditing Standards and statutory requirements, and I:

- assessed the basis upon which the accounts were prepared but, due to insufficient information was unable to assess the appropriateness of the accounting policies and disclosures used;

- evaluated the reasonableness of significant accounting estimates made by the Minister of Finance in preparing the financial report; and
- examined a sample of the evidence that supports the amounts and disclosures in the financial report.

Not all schedules required by Section 31 of the Public Finance Act (1990) were complete or made available to me.

I also noted the following with respect to the accounts:

- information submitted in some cases was incomplete or lacked supporting documentation
- accounts had not been reconciled and analysed prior to submission
- they contained many material errors which was subsequently corrected
- were not submitted by the Minister within the legislative required time-frame

I refer to the Public Finance Act (1990) section 31 (1) and 32 (1) which outline the required timeframes

Annual Accounts:

"Within a period of 6 months after the end of the financial year"

Report on the accounts:

"Within a period of 9 months after the end of the financial year"

These timeframes can only be extended with Parliamentary approval, and again this was not sought.

An audit does *not* guarantee that every amount and disclosure in the financial report is error free. The terms 'reasonable assurance' and 'material' recognise that an audit does not examine all evidence and transactions. However, the audit procedures used should identify errors or omissions significant enough to adversely affect decisions made by users of the financial report or indicate if the Minister of Finance had not fulfilled the reporting obligations.

My opinion does *not* provide assurance:

- about the future viability of the Government,
- that it has carried out its activities effectively, efficiently and economically, or
- about the effectiveness of its internal controls.

Audit Independence

The Audit Office complies with all applicable independence requirements of professional ethical pronouncements. The Audit Act (2007) further promotes independence by:

- providing that only Parliament, and not the executive government, can remove an Auditor-General, and
- mandating the Auditor-General as auditor of public sector agencies but precluding the provision of non-audit services, thus ensuring the Auditor-General and the Audit Office are not compromised in their role by the possibility of losing clients or income.

STATUTORY AUDIT REPORT For the Year Ended 31 December 2008 Tuvalu Whole of Government

I have audited the financial report and transactions of the Whole of Government as required by the *Public Finance Act 1990* (the Act). This Statutory Audit Report outlines the results of my audit for the year ended 31 December 2008, and details any significant matters that in my opinion call for special notice. The Act requires that I send this report to the Parliament.

This report is not the Independent Audit Report, which expresses my opinion on the Whole of Government's financial report. **I have enclosed the Independent Audit Report, together with the Whole of Government's financial report.**

Audit Result

I expressed a qualified opinion on the Whole of Government's financial report on the following issues:

- Material departure from generally accepted accounting practice (GAAP) in the non-preparation of financial statements in accordance with GAAP;
- A limitation of scope due to the inability to obtain satisfactory explanations and documentation regarding a number of material entries in the financial statements;
- Uncertainty in quantifying the extent of the government's liabilities and commitments in respect to the operations of Air Fiji Limited. This was due to the inability to obtain confirmations from the bankers of Air Fiji and its holding company Aviation Investments Limited relating specifically to guarantees given by the government; and
- Opinion matters raised in 2007 that still remain the case in 2008 in relation to:

- o non-consolidation of state owned enterprises
- o non-capitalisation of fixed assets and inventory
- o expenditure exceeding approved budgets
- o netting of income and expenditure in the statement of financial performance
- o capital items still being captured in the statement of financial performance
- o non-audit of budget assumptions

My audit is continuous and I may therefore identify new significant matters before the Auditor-General next reports to Parliament on the Whole of Government audit. If this occurs, I will write to you immediately.

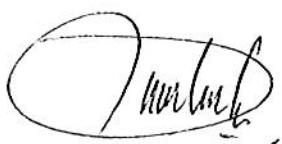
Scope of the Audit

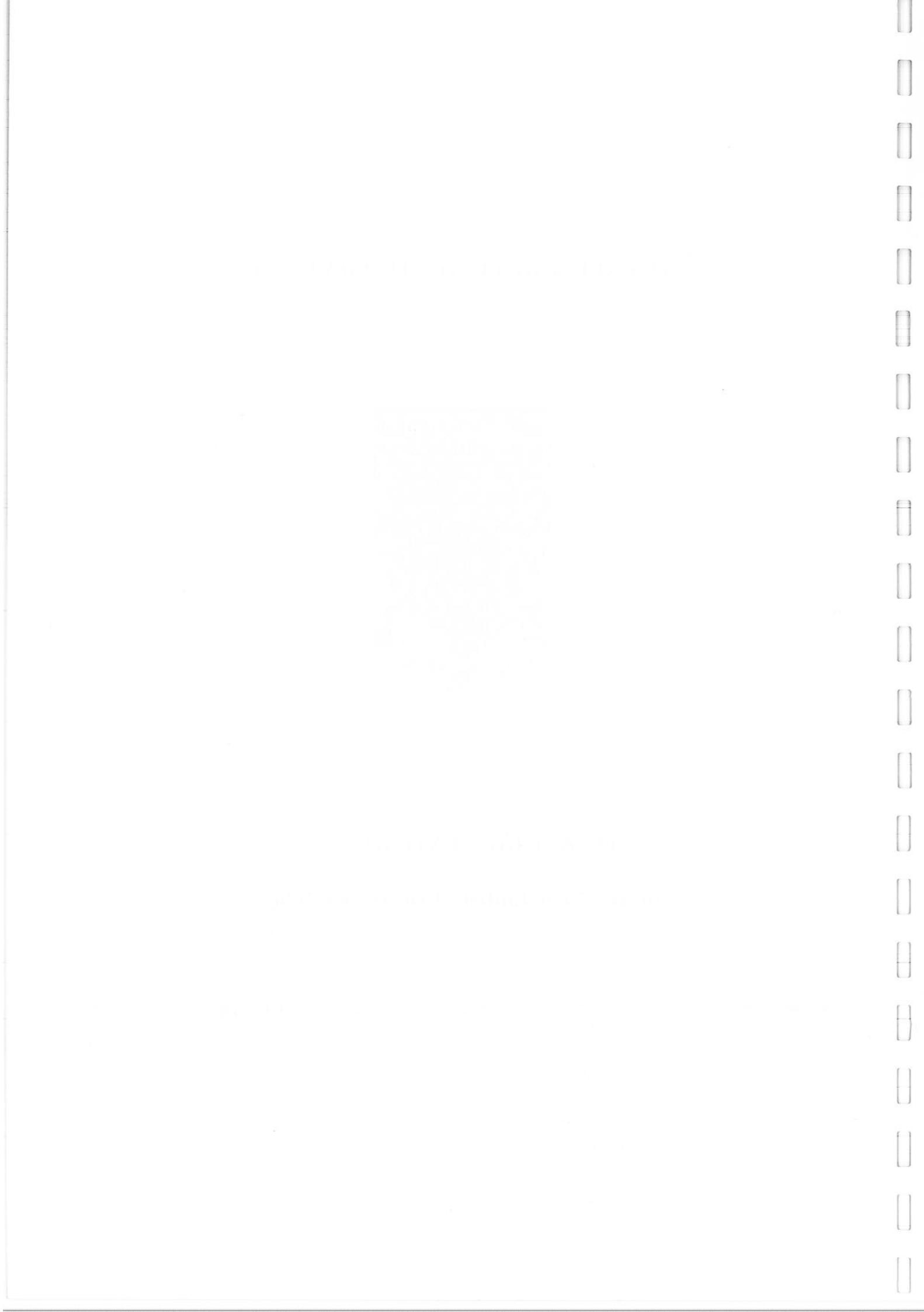

for the Year Ended 31 December 2008



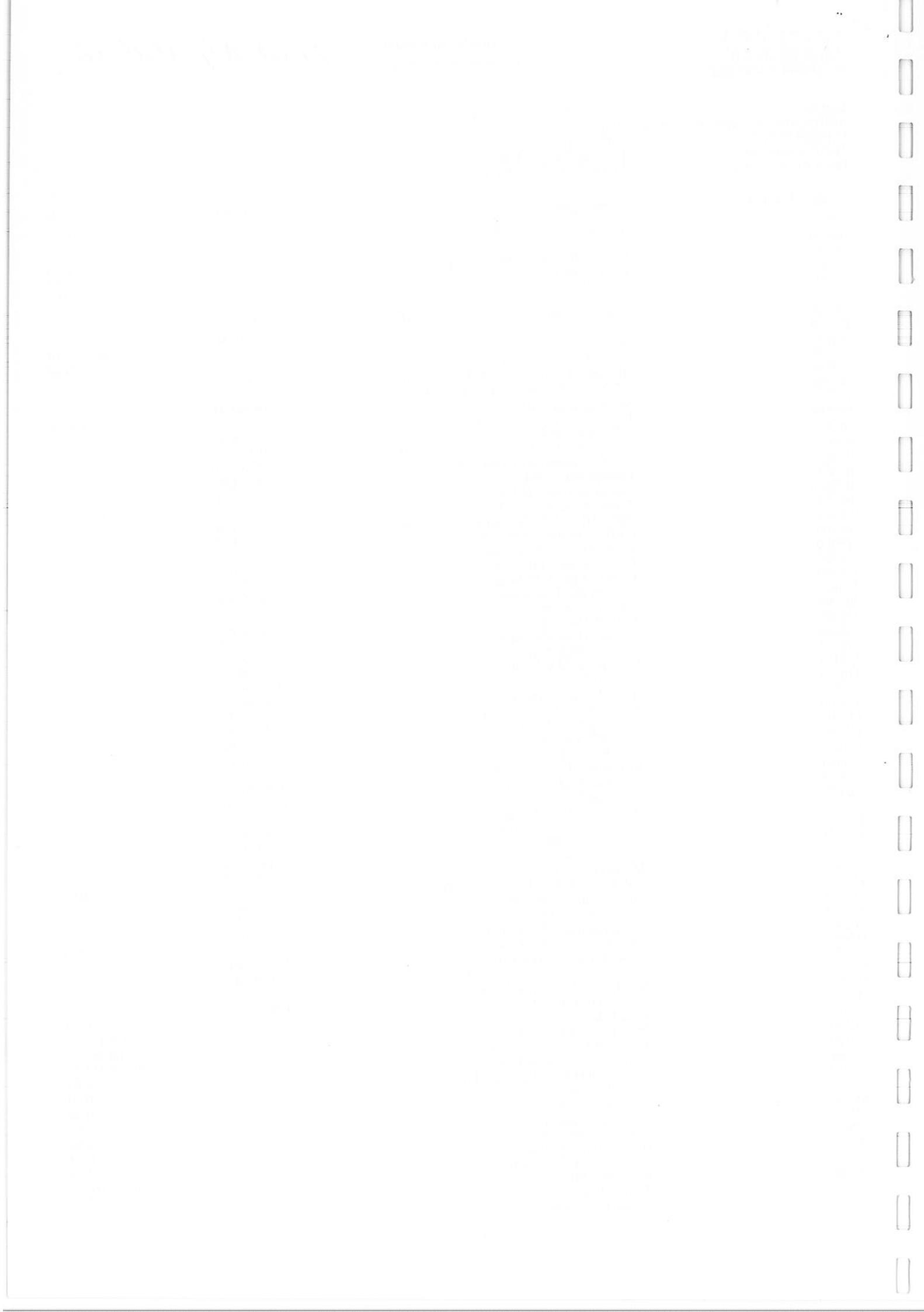
